Literature Review Updates

We continue to keep you up-to-date with healthy built environment research, policies and practices. We have added two new alerts to our fortnightly literature review searches: Global Physical Activity Network and SciVerse Scopus (SS). Our fortnightly literature review brings together key studies and their policy/practice implications for the three domains initially developed in the HBEP Literature Review: 'getting people active'; 'strengthening communities'; 'providing healthy food options'. NSW Planning Review - Green Paper and Next Steps

As many of you know, NSW is in the midst of a major review of its planning system. Given the importance of the built environment in supporting people's health as part of everyday living, HBEP has given top priority to participating in the review. The evidence in the HBEP Literature Review affirms planning's fundamental role in creating healthy built environments. The latest stage of the planning review was the July publication of a Green Paper entitled A New Planning System for NSW. As part of preparing a submission on the Green Paper, in collaboration with the Premier's Council for Active Living (PCAL), HBEP held a forum for interested stakeholders. Facilitated by Dr Danny Wiggins (HBEP Consortium Partner), participants at the forum workshopped key health promotion issues. Breaking news: HBEP is not confident that the health message is getting through – it was not mentioned at a major DP&I forum to discuss the White Paper! We need a planning system that can meet the interdisciplinary and complex challenges of the 21st Century. Keep on lobbying for healthy built environments to be part of our new planning system (we have the evidence)!

BE Healthy!

The HBEP has initiated a *BE Healthy!* campaign. While this is specifically named for Built Environment (BE) Faculty staff, *BE Healthy!* has lots of ideas to support a healthy work-place. We started by putting up signs encouraging stair use near lifts in the Faculty. We then provided information about the dangers of a sedentary working life. We have been inspired by the National Heart Foundation's *Healthy Workplace Guide*, as well as a desire to support our colleagues and students to take every opportunity to be healthy. *BE Healthy!* has three focus areas: BE Active, BE Nourished and BE Relaxed.
